Question	Answers
What grades are covered?	CTE Courses: Industry certifications hosted on the iCEV Testing Platform and <u>select</u> iCEV curriculum courses.
Is there a pre/post- test?	For the purposes of TIA, districts could use Pre/Post-test option 2.
What is iCEV?	iCEV is an all-in-one CTE solution that provides multiple industry certifications hosted on the iCEV Testing Platform, a comprehensive curriculum to teach courses across 16 career clusters, standards-aligned materials to prepare students for certification exams, and software to track, compile, and analyze critical student data.
What was iCEV designed to do?	iCEV is designed to be an all-in-one CTE solution. iCEV offers a pre-test feature, to be utilized at the beginning of a course or industry certification. The pre-test measures the knowledge and skills of state standards in a course and the knowledge and skills of the weighted industry standards tested for in a certification. After the course, a post-test with the same 50 questions is offered. After the certification preparation materials, the final certification exam measuring the same weighted industry standards serves as the post-test. Growth is measured by student and/or class improvement. In addition to the actual testing instrument, student progress can be monitored using the check-for-understandings in each lesson.
How can I use iCEV?	iCEV curriculum can be used comprehensively or supplementally and is aligned to TEKS. iCEV also serves as a testing platform for multiple organizations' industry certifications. iCEV offers optional preparation materials for these certifications, which have been cross-walked to TEKS.
Does iCEV provide expected growth targets for students?	No, the platform does not provide growth targets. However, iCEV can assist districts and teachers with setting growth targets.
How can districts use iCEV to determine end- of-year student growth for purposes of TIA?	iCEV assists districts in determining end-of-year student growth by providing detailed reports by student, class, and/or teacher detailing growth by standard between pre-test and final exam. For the purposes of TIA, districts could use option 2 with a 3rd party pre-test, the district set growth targets, and a 3rd party post-test.
